Workshop on traceability, the key to sustainability

Tools for traceability and challenges of European regulation

Objective

The topic of traceability is becoming increasingly important in the global discourse on sustainability and responsible forestry practices. This workshop will address the main challenges for traceability, as well as the key role it plays for environmental sustainability, social responsibility, market access and brand reputation in the field of forestry. Indeed, traceability is crucial to ensure that timber products are sustainably sourced, which means they originate from well-managed forests that have undergone responsible forestry practices. Traceability is also important for ensuring that the rights of local communities are respected, as they often rely on forests for their livelihoods. Furthermore, legislation that require strict traceability, such as the recent European regulation, raises the question of market access and compliance to ambitious norms.

This workshop will bring together experts and will showcase innovative tools for traceability, highlighting the need for responsible forestry practices to promote sustainable development and ensure the long-term viability of the global forestry sector.
